# Clearwater Neighborhoods Coalition July 12, 2010 Meeting Minutes

#### I. Call to Order

## **III. New Business**

- **A. Tampa Bay Buccaneers** Stephen Diss from the Tampa Bay Buccaneers spoke about a program being offered by the TBB to help build communities. For the 2010 fall football season, the TBB are offering communities the opportunity to purchase tickets at a starting rate of \$32.00. Tickets are for home games and sold at a minimum of 10 tickets per group. - **B.** Clearwater Police Department Chief Anthony Holloway from the Clearwater Police Department spoke about some updates and changes taking place within the Clearwater Police Department.
  - **a. Operation Home Run** CPD takes up to 30 kids from neighborhoods to a Clearwater Threshers home game on a Thursday, Friday, or Saturday night game. This informal event allows youth and police to interact in a fun and relaxed environment. If you have a group of youths you would like to recommend for this contact the CPD.
  - **b.** Community Liaison Officers Three CLO's have been selected, one for each district. The CLO's will be contacting neighborhood contacts to learn about neighborhood issues. The new CLO's are:
    - i. District I Sergeant Kitchen
    - ii. District II Sergeant McBride
    - iii. District III Sergeant D'Amico
  - **c. Anti-Crime Unit** Three units, one assigned to each district, that is the enforcement unit of the CPD. This unit will focus on making arrests and enforcing laws.

Other items Chief Holloway spoke about were that CPD officers will bid to work in districts for a six month rotation. Officers will utilize COMSTATLITE, a summarized computer report that provides officers with crime detail for a specific area. The Pinellas County Sheriff's Office is making countywide crime data available through its crime analysis website - <a href="http://www.pcsoweb.com/CAS/Reports.htm">http://www.pcsoweb.com/CAS/Reports.htm</a>. CPD officers are required to "Park, Walk, and Talk." The biggest drug problem in Clearwater is not crack cocaine, it is prescription pills. Also, Clearwater will be looking at the City of San Antonio, Texas as a guide towards providing some input for dealing with homeless citizens.

**C.** Clearwater Greenprint Project – Tammy Vrana and Lauren Matzke spoke about a new initiative that the city is working on to increase energy efficiency and conservation and reduce greenhouse gas emissions through the adoption of conservation and other strategies. # **IV.** Committee Reports

- **A.** Membership Committee Larry Floyd said that the membership committee obtained three different lists of neighborhood contacts in Clearwater and merged those lists into one master list of 138 contacts. He said that the group is concentrating contacts that are closest to where CNC meets.
- **B.** Website Committee Ronald Wright reported that the website is live now. Motion made by Ron Wright to set website sponsorship levels at: Platinum \$500.00, Gold \$250.00, Silver \$100.00, and Bronze \$50.00. The motion was seconded by Ron Delp and motioned passed unanimously. If you know of a potential sponsor please send the information to Ron Wright.
- **C.** Publicity Committee Carl Schrader reported that flyers are being distributed to libraries and other local venues.
- **D.** Conference Committee Doug Williams said that the mini conference is on for September 13<sup>th</sup> about the pros and cons of Amendment 4. Doug said that the conference will be in lieu of the normal monthly meeting.
- **E.** Code Committee Ron Delp said that the committee has had a meeting with Terry Teunis about neighborhood issues that were previously brought to the Code Enforcement Department. Terry said that he is trying to change culture and mindset of the employees in the department. The department is looking for faster and quicker results. There are no budget cuts proposed for this group.
- **Council member Bill Jonson -** Provided an overview of the 2011 city budget that was released. No facility closures are planned and no millage increase is planned either. Ron Delp said that the city is saying there are no millage increases planned but there are several increases in fees for services. He also said that maybe council members should be paid more to oversee the management of the city.

- **B.** Community Policing Doug Williams said that he had a pleasant experience with a Park Walk and Talk officer.
