Secretary's Report

Old Business

Urban Land Institute – Jack Mortimer stated that there were 150 residents at the ULI meeting on April 13th. A number of people felt that they were not warmly embraced by the City Council. Seven residents did have the opportunity to speak (Joe Corvino, Jack Mortimer, Mike Bennett, et al). The city reported progress on a number of tasks but most of the people expressed the desire to move forward on Coachman Park. The next forum is scheduled for September which many feel is too long. Bill Jonson said that at the work session the City Council agreed to get an update in June. Jack Mortimer wants to have the CNC to nominate Carl Schrader the community member to sit on the(CRA CDP)/Downtown Devdlopment Partnership board to represent city residents. Joanna Siskin asked if the council wants the whole city to embrace downtown? If so, they need to be able to participate. Jack invited other neighborhoods to attend their meeting next Monday 5/11 @5:30 at Waters Edge. Crestlake Park was discussed at the council work session and the result is that the memorial will be started in the fall, ending in March with no capital improvement until 2017. Carl asked what the downtown group wants. They asked for 1) a survey to be conducted and 2) a seat at the table. Jack Mortimer made a motion that the CNC insist that it be the representative of the community and have a seat at the table. And that they canvas the neighborhoods to understand what the neighborhoods want. 2nd by JoAnna Siskin. Approved unanimously.

Clearwater Marine Aquarium – Carl Schrader indicated that the CMA has decided not to sign a lease on the City Hall property and has decided to improve the facility on Island Estates.
