

## CNC March Meeting Minutes

1. The meeting was called to order by President, Karen Cunningham at 7 PM
2. Introductions of those present
3. Secretary, Sean Schrader gave an update of the February Minutes. There were no objections to the February minutes. A motion for approval of the minutes was made by Bill Jonson and was seconded by JoAnna Siskin.
4. Shelly Kuroghlian, Treasurer gave an update on the CNC's bank accounts. There has been revenue from membership dues. The treasurer encouraged those present to pay their membership dues.
5. JoAnna Siskin, Vice-President had nothing she wished to report on.
6. Clearwater Police Officer Frederick gave an update regarding current crime-related activities in the city. He discussed how vehicle burglaries throughout the city are down by 48%. The officer encouraged those present to lock their doors and secure their valuables to prevent burglaries from taking place. He encouraged those present to attend the CDP's event Coffee with a Cop event taking place in March in April.
7. Clearwater Neighborhoods Coordinator Julianha Green expressed the positive meetings that she has had so far with many neighborhood associations in Clearwater. She discussed how Neighborhoods Day is upcoming on March 30<sup>th</sup> and mentioned how there are 34 associations participating in the event. She recommended using the Social Neighborhood Platform, Nextdoor to spread news about neighborhood associations. She also discussed how boundary maps for neighborhood associations in the city are currently being created in order to spread awareness about neighborhoods in the city.
8. Carl Schrader gave a presentation about the Brookhill Neighborhood Association. He discussed how the organization first began when the CDP's Crime-Watch program first began. He then began to represent the Brookhill Neighborhood to the CNC. Once he began attending CNC meetings, he learned more about neighborhoods in the city of Clearwater. He discussed how a major Traffic Calming project took place in his neighborhood and he was able to work with his neighbors in order to get traffic calming in his neighborhood.
9. Ric Hartman, Transportation Planner gave a presentation about Complete Streets in the City of Clearwater. He gave a brief overview of Complete Streets and the purpose that they serve in Clearwater. He also discussed what planning goes into determining how traffic flows and what traffic patterns are present throughout the city.

10. Bill Jonson & David Lillesand gave updates regarding the Imagine Clearwater Plan. Mr. Jonson discussed that the Imagine Clearwater presentation made to the City Council by Webb Consultant's Duncan Webb could be found on MyClearwater.com. He encouraged those present to visit the City of Clearwater's website and to review the PowerPoint presentation that was given to the city council. The president told those present that the CNC would not be taking a position on the Imagine Clearwater Plan. She asked those present to see whether or not they wanted to take a position on Imagine Clearwater. Not enough members were interested in taking a position on this matter.
